

### Travel Safety Requirements (as of 13AUG21)

For the safety of our guests and passengers, AFC Vacations is implementing new on tour requirements. We thank you for your understanding and for doing your part to keep us all traveling safely.

### **Requirements for Passengers**

### (effective for all tours departing September 10, 2021 and after)

### **Domestic Travel Requirements (United States Tours)**

All passengers traveling with AFC Vacations within the United States, regardless of destination or point of origin, must provide one of the following three options to demonstrate wellness: proof of full vaccination against COVID-19, a negative COVID-19 test, or proof of recovery from COVID-19. Passengers will be asked to show the Tour Manager one of the following when joining their tour:

- Proof of Vaccination against COVID-19. Proof must include the passenger name & final dose given at least 14-days before the tour departure date. Proof can be a photocopy or electronic vaccination record document issued by either: (a) the health authority that administered the vaccination (i.e. U.S. CDC's Vaccination Record Card); or (b) the participant's medical provider that administered the vaccination, or (c) approved electronic certification from your county or health provider.
- **Proof of Negative Covid-19 Test** would include a verifiable negative/not detected diagnostic COVID PCR or Antigen Test with FDA Emergency Use Authorization, showing date and time of test, taken within 72 hours of the tour departure date. Electronic or Paper proof are acceptable.
- **Proof of recovery** from COVID-19 would include a copy of a positive test result dated within 3 months prior to the end of your tour, and also a copy of documentation from your health care provider that you were cleared to end isolation/quarantine. This written documentation must include your name and date of your positive test.

Depending upon your destination in the United States, there may be other requirements such as vaccination only in certain counties. Guests should monitor these requirements as well. AFC will continue to review and update our requirements as US restrictions are updated.

### Vaccination Requirement for International Travel (International Tours including Canada & European River Cruises)

All passengers traveling with AFC Vacations to any country outside of the US regardless of destination or point of origin must provide proof of full vaccination against COVID-19 for tours departing on or after September 10, 2021. International destinations have introduced vaccination requirements for indoor experiences like restaurants, attractions, museums, theaters, etc. Even though the entry requirements for that destination may not require vaccination, vaccination will be required to travel on all international tours departing on or after September 10, 2021. At this time, a negative/not detected test result for COVID-19 administered in advance of returning to the United States is also required.

Depending upon your destination, there may be other and additional country-specific and/or airline requirements for testing prior to travel. Guests should monitor these requirements as well. AFC will continue to review and update our requirements as Domestic & International restrictions are updated.

### **AFC's Commitment to Wellness**

### Q & A - AFC Travel Safety Requirements

#### How will these requirements be verified for a US Tour?

On the first day of the tour, all guests must complete and sign the AFC Wellness Survey and Waiver which will be collected by the Tour Manager. Additionally, the Tour Manager will review your proof of wellness.

#### How will these requirements be verified for an International Tour, Canada or European River Cruise? For International Tours, proof of vaccination will be

required prior to your tour/cruise. On the first day of the tour, a Wellness Survey & Waiver must be completed and given to the Tour Manager.

### What requirements apply to tours that begin in the United States but cross into Canada?

AFC has revised all itineraries for U.S./Canada crossborder tours for the remainder of 2021, to operate exclusively within the United States. Inclusions and sightseeing planned for Canada will be replaced with alternates in the United States. Tours affected include *Niagara Falls & the Grand Hotel*. Tour departures in 2022 are expected to return to the original itinerary and all passengers will need to meet the requirements for **International Travel** in place at time of departure.

### Are there any exceptions for individuals who cannot take a vaccine or who do not want to be vaccinated?

Passengers traveling on Domestic (US) Tours can also show Proof of a Negative Test or Proof of Recovery (see Requirements). We are <u>not currently making any</u> <u>exceptions on International Tours</u> to the vaccination policy. Guests who are not vaccinated will not be permitted to travel on International Tours in 2021.

# Are there any exceptions for unvaccinated individuals under the age of FDA vaccine approval?

Passengers under the age of the FDA vaccine approval, travelling on Domestic (US) Tours can show Proof of a Negative Test or Proof of Recovery (see Requirements). We are <u>not currently making any exceptions on</u> <u>International Tours</u> to the vaccination policy. Guests who are not vaccinated will not be permitted to travel so unvaccinated children would not be permitted to travel internationally in 2021.

#### What do I need to know about air travel?

Airports and airlines have developed many new policies in response to COVID-19 including, but not limited to:

• Requiring a negative COVID-19 test prior to boarding any flight that returns to the U.S.

- Wearing a face mask at the airport and onboard.
- Make sure to come prepared with your own supply of face masks.
- Bring food and water due to limited service and food onboard in most cases.

• Mandatory preflight health declaration during airport check-in.

## Will the AFC Air Department still Check me in for my flight?

Airlines are doing their utmost to ensure a very safe flying experience. One of these measures is a Health Questionnaire with a few brief and simple medical declarations at time of check in. Due to the personal nature of these questions AFC cannot answer on your behalf. This makes us unable to perform the check-in procedure that we have done for many years. However, now in your documents we will provide your individual airline confirmation number that will enable you to check in online or at the airport directly with the carrier.

#### Are guests required to wear masks?

We follow destination requirements and local, state, and federal mandates. At this time, there is a U.S. Federal requirement that masks are worn on transportation such as airlines and motorcoaches. All guests must comply with these rules.

# What if a guest has symptoms of COVID-19 during the tour?

Fully vaccinated people should still watch for symptoms of COVID-19, especially following an exposure to someone with suspected or confirmed COVID-19. If an individual develops symptoms, he or she should isolate and be clinically evaluated for COVID-19, regardless of vaccination status.

### What if a guest tests positive for COVID-19 within 14 days following the tour conclusion?

We encourage guests to contact us should they develop symptoms or test positive for COVID-19 within 14 days following their tour conclusion. There may be contact tracing conducted by AFC. We will alert the other group members of the possible exposure so that they can take all necessary precautions. AFC will attempt to protect the privacy of any individual who tests positive, though contact tracing and notification could result in guests inferring who has tested positive.
